THE CHARTER TOWNSHIP OF HAMPTON, BAY COUNTY, MICHIGAN HEREBY ORDAINS:

Section 1. <u>Purpose</u>. This Ordinance is for the sole purpose of amending Ordinance 62, by replacing APPENDIX "A", to said Ordinance 62.

Section 2. <u>Severability</u>. The provisions of this Ordinance are hereby declare to be severable and if any part is declared invalid for any reason by a court of competent

jurisdiction, it shall not affect the remainder of the Ordinance, which shall continue in full force and effect.
