Ordinance No. 22-1

## Cross-Connection Control Program Ordinance

An Ordinance to amend the Charter Township of Hampton Water Supply Cross-Connection Ordinance, being the Charter Township of Hampton Ordinance No. 22, and to authorize the Township Water Department to establish a Cross-Connection Control Program as approved by the Michigan Department of Public Health, and to adopt by reference the "Cross-Connection Rules Manual" as published by the Michigan Department of Public Health.

THE CHARTER TOWNSHIP OF HAMPTON, BAY COUNTY, MICHIGAN ORDAINS:

#### Section 1 - Short Title

This Ordinance shall be known as the "Cross-Connection Control Program Ordinance."

#### Section 2 - Amendment to Ordinance No. 22, Section 3

Section 3 of Ordinance No. 22 is amended to read in full as follows:

"That it shall be the duty of the Township to cause inspections to be made of all properties served by the public water supply where cross-connections with the public water supply is deemed possible. The Township Water Department shall establish a Cross-Connection Control Program in accordance with the "Cross-Connection Rules Manual" published by the Michigan Department of Public Heath, which "Cross-Connection Rules Manual" the Township hereby adopts by reference. The frequency of inspections and re-inspections for cross-connection with the public water supply shall be as established in the "Cross-Connection Rules Manual." A copy of the Cross-Connection Control Program and the "Cross-Connection Rules Manual" shall be available for examination by the public during normal business hours at the Township Water Department and at the Office of the Township Clerk and shall be available for public distribution at a reasonable charge."

## Section 3 - Penalty

The penalty for violation of this Ordinance shall be the same as the penalty imposed by Section 8 of Ordinance No. 22.

### Section 4 - Separability

If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision and such holding shall not effect the validity of the remaining portions thereof.

# Section 5 - Ordinance Repealed

All ordinances or parts of ordinances in conflict with the provisions of this Ordinance are hereby repealed.

# Section 6 - Effective Date

This Ordinance shall take effect 30 days after its publication following its adoption.
