

STORMWATER POLLUTION SOLUTIONS

5 SIMPLE WAYS YOU CAN HELP THE GREAT LAKES



Limit your pesticide and fertilizer use. Pesticides are one of the biggest pollutants of all. Limit fertilizer use, and make it a habit to sweep your grass clippings onto the lawn rather than into a catch basin.



Check your vehicles for fuel and oil leaks. When it rains, grease and oil drippings wash into storm drains, and go straight into our rivers and streams.

Wash your car on the lawn or go to a car wash (where the water goes to a wastewater treatment plant). Dirt and oils you wash off can harm fish and animals if it goes straight in the storm drain. Grass filters pollutants — and you'll water your lawn at the same time!



Only Rain Down the Drain! In other words, use trash cans! Even if it means a slight inconvenience for you, it's better off for everyone who shares Michigan's rivers.

BRUSH CHIPPING

Brush Chipping is scheduled to begin the 1st Tuesday of every month (weather permitting and emergencies take priority). The DPW will travel the entire township, so brush must be out before the 1st Tuesday of the month as the route they take may change each month. Brush not put out in time, will be left for the following month.

There is no list that you need to be put on.

10 minutes **MAXIMUM** per location

Nothing larger than a 4" diameter

Stacked neatly with all ends facing the road

Last Brush Chipping, weather permitting will be November

Hello Township Residents,

I would like to share some good news and updates with you:

- ♦ Consumers Energy Update—On April 20, 2022, Consumers Energy announced that the Karn 3&4 natural gas and fuel oil generation facility will NOT close in 2023 as announced in 2021, but will remain open until 2031. This is great news for Hampton Township!
- ♦ American Rescue Plan (ARPA)—Hampton Township received the first installment of the funds and has been working on the following projects to date:
- Water main extension project to eliminate a dead end on Burns Road. (completed)
- ADA automatic door openers at the Township Administration Offices. (completed)
- DPW has completed some ditch digging/cleaning. (ongoing)
- Finn Road Park and Pondside Park Improvements—Grant applications have been submitted to the Michigan Department of Natural Resources (DNR) for new playground equipment at both parks and a kayak launch at Finn Road Park and a walk path around Pondside Park. If grants are awarded, ARPA money can be used for the required match dollars from the Township. This will increase the total project budget.
- Updating the Hampton Township hall and administration building electrical panels.
- Generator purchase for Township Hall—Currently the hall does not have a generator.
 The Township hall is a designated American Red Cross site should there ever be a need in our area. The electrical contractor is waiting on parts. Installation should begin
- ♦ Residential Construction is still happening in many areas in Hampton Township and we are hoping to see the trend continue.
- $\Diamond\,$ Hampton Township Audited Financial Statements are available on our website.

Primary Election will be held on August 2nd & the General Election will be on November 8th.

We received many back and she has been reviewing each one to see if the voter actually still lives in the Township. You do not need this card to vote.

Hampton Township PUBLIC SAFETY



FROM THE DESK OF BRYAN BENCHLEY DIRECTOR OF PUBLIC SAFTEY

We are very pleased to announce that our newest Public Safety Officer, Shaun Bacon, has graduated from the Bay City Fire Academy and also completed his medical first responder training giving him a state M.F.R. license. Shaun is one of 9 other officers, myself included, that serve our residents. We also have a fulltime fireman that works out of the station along with a Part-time fire chief and 12 paid-on-call firefighters that serve the township as well.

We have been very busy applying for grants from various agencies to update our aging equipment. We received a grant from Meijer to purchase new flashlights, we've applied to AAA to purchase a speed radar trailer that we would set up in areas of speeding complaints. We have also applied for and been approved to receive funds to purchase a new patrol car. Because of the multiple job duties your officers do now, I have ordered a truck as our newest patrol car. The truck will allow officers to store their fire gear, medical gear, and police gear in the back on a slide out tray. Currently all of that gear is stored in the back of the cruisers piled up creating a vision obstruction for the officers.

I report monthly to the Federal Government for use of force incidents. Last October was the first time I've



had to report a number to them. Our Officers stopped to check on a vehicle parked at Finn and Arms. As the Officers exited the patrol car, a subject had pulled up a shotgun and shot at the officers. Each officer shot one round back towards the subject as they were taking cover behind the patrol car. He had barricaded himself on the opposite side of his car and after over an hour standoff, the incident ended peacefully with no one sustaining any injuries. The patrol car had suffered a shot out window. We live in a great community with great residents but it just shows that bad things can happen at any time. This subject was not a resident of this community nor this state.

Please remember that if you need to do some branch burning etc., to contact the fire stations to get a burn permit. At times the state will ban any burning and we must follow the states rules. Also, we do offer residential house checks to residents if they leave for an extended period of time. Just come to the Police Department and fill out a vacancy form and your home's exterior will be periodically checked by officers.

It's always a pleasure to serve the residents of Hampton Township.
