DPW ADMINISTRATOR BENCHLEY: restoring lawns from water main breaks, replacing meters, completed a water tap, had a sewer back up, and sold the old brush truck for \$8,300.00.

PUBLIC SAFETY DIRECTOR BENCHLEY: new police trucks are getting detailed and old vehicles are getting equipment removed, had 11 accidents, 15 arrests, 27 medical calls, 50 traffic stops and 254 calls for service since the last Board meeting.

COUNTY COMMISSIONER POIRIER: Reported he attended the Bay County Road Commission and Bay County Department of Water and Sewer meetings, spoke about replacement of lead water services, microplastics in bottled water, and will begin working on the 2024 budget.

Mary Smith inquired about the sewer back up at the Sr. Citizen building.
